He oversees teams across the globe with the mission of improving the teaching and learning of STEM subjects. He has devoted his career to helping students strengthen their knowledge and build confidence in pursuing advanced STEM courses creating paths to rewarding careers.

Shelly Dee, Owner of the Creede Hotel and Restaurant and The Stables at the Rio Grande, an events venue in Creede, CO. She serves on the board of the Hoglund Foundation and has done so since its founding over 30 years ago. Additionally, she currently serves on the boards of UNICEF USA, Friends of Maiti Nepal and KERA. Internationally, Shelly was the first American to serve on the Development Committee for the Board of The Natural History Museum in London. In Singapore she served on the Board of the National Museum and created the docent training program at the Asian Civilizations Museum.
